### **Action Item Review**



#### Imaging Power Management

- Candidate Standards approved 14 February 2011
- Project Charter proposed an Interoperability Event Q2 2010 (assuming a mid 2010 approval)
- ➤ Interoperability Event, perhaps in preparation for advance to full PWG standard, would use the MIB as a validation of both the MIB and Model standards.
- Questions:
  - Do we have candidates for interoperability?
  - Event would involve?
    - Loading MIB into MIB Browser application such as MG Soft
    - Doing a MIB Walk to determine what objects are supported
    - Checking that status objects reflect all identified device power states
    - Exercising settable objects (how many objects, how many values?)
  - Do we establish and document operability test first?
  - Do we have "event" a la bakeoff, or allow companies to run the procedure, providing the printouts to the working group for validation?

### **Project Charters**



- ❖ WIMS/PMP is concerned with the management of networked hardcopy imaging devices. WIMS has existed for some eight years as a semi-permanent working group. PMP, the PWG MIB Working Group has its origins in the IETF Printer Working Group, the immediate antecedent of the PWG.
- Over this period, the group has continued to address management issues and has produced several noteworthy standards. Participation has gone from moderate to miniscule, with one main contributor and several offering occasional support.
- WIMS has gone for some time without the required vice chair and secretary offices being filled.

### **Project Charters**



- Three new projects have been identified, and although there has been some interest in pursuing them, they may not have the excitement of other PWG projects and may not get the attention that they require.
- ❖ For this reason, and in keeping with current PWG practice, Project Charters delineating the objectives and timeframe for the projects have been created.
- ❖ To encourage PWG-wide awareness and wider participation in these projects, we are also seeking formal PWG approval for each of the projects.
- Criticism of and comments on the charters are solicited.
- ❖ It is hoped that approval of a WIMS project charter indicates willingness to contribute to the effort, at least to the point of seriously reviewing the documents during development.
