3. Review model

 - b. Resume at section 3.4
 - c. Section 3.5.2:
 - Lines 596-597 (item 8): Reword "A log of all Jobs transactions is maintained by the Cloud System Control Service or its constituent Services, ..."
 - d. Section 4.1.1: "The Cloud Imaging System contains a ...", "and can contain any number of ..."
 - e. Figure 2: Remove xform service from Cloud Imaging System and Local Imaging System
 - Q: Leave Xform in the CIS, just not connected to Client or Proxy?
 - Would require a little explanation to avoid confusion
 - Key element is that it should not be connected directly to client or proxy (for the cloud model, anyways; direct usage follows standard Semantic Model)
 - f. Section 4.1.2.1:
 - Make sure minimum list of elements is reflected in the tables later in the document

- Item 2: Add SystemXriSupported (or the equivalent element to ServiceXriSupported) pointing to the System Control Service
- g. Global: "Offline" instead of "off line" or "off-line"
- h. Global: "Online" instead of "on line" or "on-line"
- i. Global: "Down" instead of "down"
- j. Add Down, Offline, Online as defined terms
- k. Action: Mike to check the style for the 4th level heading in the WD template
- l. Figure 4: Tweak size to keep the right hand "local imaging system" on the page
- m. Section 4.2.1:
 - Line 910, 915: Drop "Candidate Standard" from title of 5108.01.
- n. Table 1:
 - For Semantic Model: Consider making LastDocument required for 3.0 (IPP makes it required)
- o. Section 4.2.1.1:
 - Line 952: Add "s" to AddDocumentImage
 - Reference old AddHardcopyDocuments operation?
 - Line 955-956: Move "such as FaxOut" after "applicable to Services"
 - Maybe clarify that SendDocument/Uri deal with digital documents while AddDocumentImages deals with Hardcopy documents (might just need to rearrange a little)?
 - This will be a point of discussion for SM 3.0 (new shared InputElements group for all hardcopy input)
- p. Section 4.2.1.2:
 - Q: Make Target Device optional (as in IPP)?
 - If so, need to talk about what to do if no target is specified (see discussion in IPPSIX)
 - Extra space before period on line 987
- q. Global: "Canceled" instead of "Cancelled", etc. (one L)
- r. Section 4.2.2:
 - Line 1014: The content of requests and responses *is* typically reversed ...
- s. Stopped at section 4.2.2
