 - Use of RAR allows for scope/user access token reuse, no additional user interaction required for different groups
 - With OAuth scopes you have to go back through the authentication web page if they don't match
 - Make RAR required to support by Clients, optional for Printers (depends on AUTHZ to support0

- Client MUST:
 - Use any scopes advertised by Printer to get session/user access token
 - Use RAR if types advertised by Printer to get printer group access token
 - Use token exchange if supported by AUTHZ to get printer access toien
- Can't only use RAR because it is too new and isn't implemented yet
- Can't eliminate scopes entirely because scopes are part of core OAuth
- PWG isn't in a position to push a particular standard for OAuth
 - but we can maker recommendations/best practices (good/better/ best like IIG)
